- i. **Most important** : Following links of Amrit Mahotsav website to be checked to avoid duplication of stories

- ii. The DDR story has to be necessarily related to freedom struggle against East India Company / British, Dutch, Portuguese, French Rule in India.
- iii. *List of freedom struggles for grant of freedom fighter pension given in MHA website is a guide for reference. The details are as follows:-*

- iv. The list of MHA is only illustrative, not exhaustive in nature. As for example, First War of Independence in 1857, Paik Rebellion in Odisha in 1807 and numerous popular tribal, peasant movements against the British as well as against the local zamindars, money lenders may be considered as freedom struggle.
- v. Story to be written in own language in simple English, Font-Arial, Size-12 in MS Word
- vi. Source of story to be mentioned
- vii. Contents from internet, wikipedia, published material not to be copied
- viii. Focus may be on *janmabhumi*, *karmabhumi*, *place of martyrdom*, *name of event/freedom struggle*
- ix. In Personality try to avoid prefixes like Mr., Mrs., Sh., Smt. & Suffixes like ji (except Gandhiji)
- x. Photographs to be shared :-
 - Gallantry awards, testimonials received during World War I & II, participation in INA, Royal Indian Navy Mutiny (1946), *tamrapatra* awarded by Government of India in 1972, 1984, *tamrapatra* awarded by State Governments, *tamrapatra* awarded by INC on its centenary in 1985, *tamrapatra* awarded by INA Centenary Committee, other recognitions by state government to be shared.

- Houses, memorials, educational institutions, courts, jails, forts linked with freedom struggle to be shared
- xi. Certificates issued by Jail Superintendent mentioning cause and period of detention, wherever available should be provided
 - xii. Freedom Fighter Pension papers issued by MHA, Govt. of India or State / UT Government wherever available should be provided.
 - xiii. Name of freedom fighter has to be clearly visible in the *tamrapatra*, jail record, pension paper etc.
 - xiv. Where photographs are not available, illustrations/sketches/old rare maps etc. to be used
 - xv. Jungles, caves, rivers, lakes where freedom struggle had taken place to be shared
 - xvi. Any day of remembrance day for paying tributes being observed to be shared
 - xvii. Any road, chowk, public institutions like school/college etc to perpetuate the memory to be shared
 - xviii. Archival material like old newspaper articles, letters from family/friends, records from jail, school, college to be used in story
 - xix. Vernacular sources (like newspapers) to be used
 - xx. Source of photographs, videos to be mentioned (Wikimedia Commons may be explored). Photograph / Image may should be cropped properly.
 - xxi. Copy right issues will arise if you use photographs of Getty images, Almaty etc. Therefore, these sources should be avoided. Preference to be given for Government sources like district gazetteers, government websites.
 - xxii. Before submission of stories, proof/spell-check may be done.
 - xxiii. Art, culture, places of tourist attraction without connect with freedom struggle to be avoided.
 - xxiv. Students / Research Scholars may consider utilising the resources given below :
 - District Information Officer (Art, Culture, Tourism)
 - District Collector Office (Freedom Fighter List)
 - Visits can be paid to freedom fighter's houses and Oral History to be recorded along with collection of testimonials
 - Freedom fighters memorials installed during *Meri Matti Mera Desh* campaign from 1st September to 30th October, 2023.
