**Subject: Regarding recruitment for the 09 posts of Field Officer at CCRT, New Delhi.**

Centre for Cultural Resources and Training (CCRT) vide Advt. No. NIL dated 21<sup>st</sup> January, 2023 invited Offline applications for filling-up 09 posts (05-UR, 02-OBC, 01-SC & 01-EWS) of Field Officer in Level-07 of Pay Matrix as per 7th CPC for Field Officer, CCRT, New Delhi. The Screening Committee has scrutinized the applications of the applicants in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post as per the Recruitment Rules of CCRT..

The following essential criteria were mentioned in the advertisement:

**Essential :**

- (i) Post Graduate from a Recognized University in Art/Culture/History/ Anthropology/Sociology.
- (ii) Two years experience of organizing and conducting conferences/seminars and workshops etc.

Note 1: Qualification (s) are relaxable at the discretion of the Competent Authority (Search-Cum-Selection Committee/ Departmental Promotion Committee), for reasons to be recorded in writing, in case of candidates otherwise well qualified.

Note 2: the qualification (s) regarding experience is relaxable at the discretion of the competent authority (Search-cum-Selection Committee/ Departmental Promotion Committee), for reasons to be recorded in writing, in the case of candidates belonging to Scheduled castes or scheduled tribes if at any stage of selection the competent authority is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancy reserved for them.

Based on the criteria mentioned above, **out of 148 applicants, 59 applicants have been provisionally shortlisted for further process/ next stage.**

**Please note that**

1. The Short listing for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Mark sheet, Experience & Salary etc. which he/she have mentioned in his/her offline application.

2. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled.
3. Verification of documents will be done at later stage in the Selection process.
4. **If it is found that applicants have furnished false or wrong information, their candidature will be rejected at any time/ any stage.**
5. CCRT reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof. No compensation / claims will be entertained on account of this.
6. This post is pertaining to All India Service Liability and selected candidates may be posted in CCRT HQ or Regional Centres.
