- **6.** The EMD of successful bidder of Rs.1000/- (Rupees one thousand only) will be retained by CCRT as a performance security deposit and same will be refunded on successful completion of period of the contract.
- 7. The firm which is awarded the contract shall carry regular and periodic preventive maintenance checks. The firm which is awarded the contract shall also furnish the 24 Hrs. Helpline telephone numbers, besides mobile number and engineers, on which they can be contacted if needed at odd hours for any repair/maintenance jobs.
- 8. The contract is for a period of one year w.e.f. **01-08-2024 to 31-07-2025** which may be extended, on the same rates terms and conditions for a further period of one year, mutually agreed upon by the firm and the Director, CCRT, subject to satisfactory performance during contract period.
- 9. The Firm which is awarded the contract, will ensure that the complaints regarding breakdown of the telephone systems are attended on the same day and in case of any spares required, it needs to be completed in 48 hours. Request of supply for consumables should be attended within 24 hours. In case of any delay, the firm will intimate the CCRT for delay with sufficient reason. In case of delay without any specific reasons penalty @ Rs. 100/- per day will be imposed till the complaint is attended and machine repaired.
- 10. All disputes are subject to Delhi Jurisdiction only.

11. Payment will be made on half yearly basis after submission of the bill by the vendor alongwith satisfactory report service for AMC equipments from every section/departments of CCRT.

Scope of Work:

- 1. The System being taken under contact will be inspected by service engineer of "Vendor" in presence of CCRT Official to ensure that equipment is functioning properly.
- 2. The old parts and dismantled equipment/ material shall have to be deposited to CCRT.
- 3. Provision of maintenance services will be confined to "Vendor" within (09:30 AM to 05:30 PM) i.e. in working hours.
- **4.** The contract will cover mentioned equipments and accessories without material (Non Comprehensive).
- 5. During the contract period company's engineer/technician shall attend break down unlimited calls/complaints within 24 hours.
- 6. "Vendor" shall not liable for any failure to perform any of its obligation if such failure due to force major accident, strike, fire, storm, flood, earthquake, explosion, lock out, industrial trouble, high voltage, lighting, transportation, embargo or any such kind of measure taken by the Government.
- 7. In case of any accident happened during the execution of work, CCRT will not entertain any claim, compensation, penalty etc. on this account.
- 8. If repair/replacement are necessitated by the CCRT then "Vendor" shall claim additional charges on this account.
- 9. "The firm" shall rectify, if there is any fault in the cabling in connection with system. However if any fault in cable, telephone accessories has to be replaced and shifting of EPBAX, intercom another location is involved, the charges for the same will be paid extra.

10. Any complaint lodged from this office will be attended with in 24 Hrs. if the company fails in it the penalty @1% of contract value per day will be charged subject to maximum of 10 days and beyond this contract shall be terminated.
