It is also needless to mention that the above said teachers who have been deputed from their respective State Education Department must fulfill the guidelines mentioned below:

• Teachers should be up to 52 years of age at the time of registration (It is mandatory to provide proof of date of birth at the time of registration)

- Teachers belonging to various disciplines e.g. Language, History, Geography, Civics, Mathematics, Science (s), Fine Arts, Commerce, Economics, Music, etc. should be recommended for the course. The name of the teacher belonging to Yoga, Physical Education and SUPW disciplines <u>must not be recommended for training</u>. Only one teacher should be recommended from one school at a time for the Orientation Course.
- Teachers teaching in classes 6th/7th/8th/9th/10th/11th and 12th only should be recommended for deputation. <u>Primary School teachers and Headmasters/Principals, should not be recommended for participation in Orientation Courses.</u>
- The teachers <u>who already have attended the Orientation Course or Orientation (Basic Foundation)</u> <u>Course should not be deputed/recommended again.</u>
- Teachers on <u>contract/probation should not</u> be deputed as only regular teachers are eligible for Orientation Course in line with NEP 2020.
- Teachers having a minimum of 02 years teaching experience should be deputed.

For registration on the first day of the Workshop and for payment of TA on the last day of the Workshop, the deputed teachers must bring the following certificates on separate sheets of paper: -

- (i) Date of Birth Proof
- (ii) Relieving Certificate from the School
- (iii) Basic Pay Certificate
- (iv) Two passport size photographs
- (v) Cancelled Cheque/Photocopy of Front page of passbook
- (vi) Tickets/Ticket Nos. (Original of the onward journey performed and photocopy of the return journey). To and fro tickets of the entitled class and by shortest route should be purchased for the journey.

Therefore, it is requested that State Education Department and concerned relieving authorities must ensure that the teacher must fulfill the guidelines and if they failed to do so, they will be relieved and will not be registered.
