During the Refresher Course, feedback sessions will be organized on the use of CCRT Educational Kit material in schools. Teachers will also be acquainted with the innovative methodologies/techniques for integrating cultural inputs, more effectively in teaching-learning process in class-room situation.

The Objectives of Refresher Course are: -

- to obtain feedback on use of educational kit in schools;
- to draw inferences from the experience of trained teachers;
- to explore possibilities for using educational kit in classroom teaching;
- to suggest follow-up activities to be undertaken in schools;
- to motivate teachers to undertake cultural education in schools.

The Refresher Course is designed to achieve the said objectives through discussions, talks/lectures/lecture-demonstrations with special emphasis on cultural education in schools. It aims at giving fresh ideas to trainees on introducing cultural component in education. It also provides an opportunity for participants to interact with each other and to discuss the problems while using the educational kit in school(s), to find solutions and give feedback to the CCRT.

The boarding and lodging arrangements have been made at the venue.
