- 1. The detailed advertisement and prescribed Application Format are available in CCRT website <u>https://ccrtindia.gov.in</u> and interested/eligible candidate may submit the application in the prescribed format along with all the relevant documents forwarded to **Director**, **CCRT**, **15-A**, **Sector -7**, **Dwarka**, **New Delhi THROUGH PROPER CHANNEL and** scanned copies of the same may be sent to the Email: <u>dir.ccrt@nic.in</u> as an advance copy for scrutiny purpose.
- 2. The application should be forwarded through their principal employer along with last 5 years APARs, Vigilance Clearance Certificate, Integrity Certificate and Cadre Controlling Authority Certificate in case of candidates applying on deputation basis.
- 3. The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for appointment by promotion.
- 4. The Period of deputation (including short term contract) including period of deputation (including short term contract) another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed four years.
- 5. For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1<sup>st</sup> January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended), shall be deemed to the service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay/pay scale and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any up-gradation.
- 6. The last date for receipt of duly filled in Application form is 45 (Forty Five) days from the date of publication of Advertisement in Employment News. The ending date of the week for publishing of advt. in the Employment News shall apply.
- 7. Any addendum/corrigendum shall be posted only on the CCRT's website.
