Roles and Responsibilities of DRPs:

As a DRP, you will:

- Act as a **Master Trainer** and **National Cultural Ambassador** for CCRT, conducting short-term workshops in your district.
- Maximize the outreach of CCRT's initiatives, including scholarships, fellowships, training programs and Extension Services and Community Feedback Programme (ESCFP).
- Regularly coordinate with State Education Departments to increase teacher participation in CCRT programs.
- To assist CCRT in organizing seminars and conference implementation of CCRT's training programs in your state by coordination with State Education Department.
- Facilitate the organization of district-level cultural activities and campaigns in alignment with CCRT's objectives in your respective Districts.

To organize the programmes on the theme of **"350 years of the Martyrdom of Shri Guru Tegh Bahadur Ji"** the District Resource Persons shall serve as the principal field-level coordinators and facilitators for implementation of the programme in their respective districts.

The DRPs shall:

- Coordinate with identified schools.
- Liaise with Government & Government-Aided Schools
- Liaise with local Gurudwaras and community representatives.
- Conduct structured educational presentations.
- Organize student participation activities.
- Ensure observance of dignity and sanctity of the commemoration.
- Submit photographic and narrative reports to CCRT.
- Maintain participation and attendance records.
- Facilitate local publicity and outreach.

- i) **Educational Presentation Session**, ii) **Heritage Quiz Competition**, iii) **"Five Things I Learnt" Reflective Writing Activity/ story telling**, iv) **Classroom / Board Decoration Activity/ story telling activities**, v) **Poster Making Competition**, vi) **Exhibition Corner / Cultural Learning Space for organizing art & craft activities on the above theme of Life and teachings of Guru Tegh Bahadur Ji**, vii) **Community Interaction Session**, viii) **Seminar / Lecture Session (Where Feasible)**, ix) **Pledge / Value Education Session**.


