Item No. 5 Approval on Annual Accounts of the CCRT for the year 2024-25 and Audit Report of CCRT for the year 2023-24 & 2024-25.

a. Annual Accounts for the year 2024-25

The Executive Committee, CCRT approved the Annual Accounts of CCRT for the year 2024-25. The Executive Committee was informed that the Annual Accounts for the year 2025-26 will be prepared by May, 2026.

b. Audit Report for the year 2023-24 & 2024-25

The Executive Committee, CCRT approved Audit Report for the year 2023-24 and 2024-25 received from the Director General of Audit (Central Expenditure), New Delhi.

Item No. 6 Appointment of C&AG empanelled Internal Auditor in CCRT

The Executive Committee, CCRT approved the appointment of C&AG empanelled internal auditor M/s Manoj Vatsal & Co., Chartered Accountant as Internal Auditor of CCRT initially for the period of one year and which may be extended further up to three (03) years on the basis of performance.

Item No. 7 Status of Construction of Kala Gurukul and Kalagram at CCRT, New Delhi

The Executive Committee, CCRT was apprised of the status of the construction of Kala Gurukul and Kalagram at the CCRT Complex under the AKAM Project. It was informed that the work is being undertaken by CPWD.

The Executive Committee, CCRT also suggested to organize regular meetings with CPWD officials regarding the progress and completion of work of Kala Gurukul and Kalagram on timely and priority basis.

The Executive Committee proposed to initiate steps to finalize MoU's / Agreements with various Central /State Government bodies which are to be associated with the aforesaid project in CCRT.

Item No. 8 Approval of the proposal for increasing the sanctioned strength of CCRT in view of expansion of its mandate and outreach with the regular allocation of various mission based and project-based work allocated to CCRT.

The Executive Committee, CCRT gave its in-principal approval for the proposal for a comprehensive review and increasing the sanctioned strength of CCRT and revision of Recruitment Rules (RRs) of all posts in CCRT.

Item No. 9 Pendency of payment to CPWD for Construction of CCRT Regional Centre Building at Udaipur.

The Executive Committee, CCRT noted the current status of construction progress at CCRT Regional Centre building at Udaipur and proposed to explore alternate means for the construction of boundary wall. Thereafter, the budgetary proposal may be forwarded to Ministry of Culture.

- The Executive Committee, CCRT was informed that Phase I (written examination) for all 22 posts was successfully conducted from 22/02/2025 to 25/02/2025. The result for the posts of DEO, LDC, Accounts Clerk, Copy Editor (English & Hindi), Craft Instructor and Coordinator (CIC) and Video Editor have been declared and uploaded on the official website on www.ccrindia.gov.in. The result for the remaining posts will be declared in due course.
- Item No. 13** **Proposal for enhancement of Medical allowance in the form of reimbursement for CCRT**
- The Executive Committee, CCRT considered the proposal for enhancement of the medical reimbursement limit for serving as well as retired employees of CCRT. After due deliberation, the Executive Committee approved the enhancement of the existing OPD medical reimbursement ceiling from Rs. 10,000/- to Rs. 1,00,000/- per financial year.
- The Executive Committee also recommended to explore onboarding of Medical Insurance schemes on a premium contribution basis (Contributory Health Scheme) for regular CCRT officials from Govt. approved insurance organization/agencies. The Executive Committee, CCRT further directed that the approved proposal may be placed before the Finance Committee of CCRT for its consideration and formal approval.
- Item No. 14** **Preparation of Repertory of CCRT's Scholar artist and fellows and organization of seminar and festivals**
- The Executive Committee, CCRT considered the proposal and approved that the repertory / database of all scholarship and fellowship awardees across India, to be utilized for institutional collaboration and organizations of National level cultural festivals / programmes.
- Item No. 15** **Enhancement of Scholarship Amount and Tuition Fee under Cultural Talent Search Scholarship Scheme (CTSSS)**
- The Executive Committee, CCRT considered the proposal and approved the enhancement of Scholarship as under:-
- Scholarship amount – from Rs. 300 to Rs. 500/- per month
Tuition Fee – from Rs. 750 to Rs. 1,000/- per month
Total: from Rs 1,050/- per month (Rs. 12,600/- p.a. per scholar) to Rs. 1500/- per month (Rs. 18,000/- per annum per scholar)
- The proposed enhancement will entail an additional financial implication of approximately Rs. 1.90 crore per annum. In view of the financial constraints of CCRT, it is

proposed that the additional requirement may be supported through budgetary allocation from the Ministry of Culture.

The Executive Committee, CCRT further directed that the approved proposal may be placed before the Finance Committee of CCRT for its consideration and formal approval.
